Nine cowboy shooters participated in the match. It was good to have a couple of cowboys who were on their way to the Siege in St. Augustine to stop by on their way – **Big Six Henderson** from Kentucky (this man can handle an '87 shotgun!), and **Cumberland Drifter** from Tennessee.

After the first stage, there were only three clean shooters left, and shortly thereafter, the misses and P's got them as well – so there were no clean matches this month! Even those big 24"x24" targets at 6 yards could be missed.

Wabash Valley Slim was *Top Gun*, while **Big Country** and **Cumberland Drifter** rounded out the *Top Three* for the match.
