## Rooster Ray wins the March 2019 Shootout

Rain, Rain, Go Away! Due to flooding conditions at the range, we have not been able to have a cowboy match since November, 2018! The rain this week has kept the range wet and muddy, **but Big Country** and **Goliath** were able to get a couple of bays set up on Friday morning in the rain. On Saturday morning the rains had started again, but the rain stopped about 8:30, so we were able to shoot the match without being in the rain. The sun even came out a few times, warming us up quite well.

Five brave cowboys rode in for this shootout. Three of them traveled a couple of hours to shoot with us. Some of our regulars had other obligations, but the ones who came made up a hard working posse that kept the match moving right along.

We set up six stages in two of the bays on the Action Pistol Range, and had to arrange a couple of targets for the last two stages. We had planned some down-range movement, but in light of the wet conditions, we shot from under the shelters.

There were no clean shooters at this match – everybody had at least two misses. But there were no P's!

**Rooster Ray** was Top Gun, with **Big Country** and **Goliath** coming in Second and Third, respectively.

For each stage, we all preloaded and left the weapons on the

loading tables. That way, everyone could pitch in with the timer operation, score keeping, spotting, resetting and picking up brass. The match ran very smoothly, so that we were able to finish all six stages and had all the steel put away before 11:00 pm.

Thanks to **Big Country** for his help in getting the steel set up, and all the cowboys who helped with getting the steel picked up and put away, as well as those who helped with all the small details that have to be taken care of at the end of the match.
