Wabash Valley Slim was Top Gun, with **Bucky Buckskin** and **Big Country** coming in Second and Third, respectively.

Thanks to **Big Country** and **Goliath** for getting the steel set up, and to all the cowboys who helped with final setup on Saturday morning. Also a big thanks to all those who helped with the tear-down and getting the steel picked up and put away, as well as those who helped with policing the range and all the small details that have to be taken care of at the end of the match.
